Before filling out the application form, **please read the following instructions:**

- This application must be used by students who are at least a **junior level** who are currently attending school and who are entering or returning to college in an agricultural/horticultural related field in the fall. **You must maintain a 2.5 GPA or better to apply and plan to pursue a career in pest management.**
- **Include current official transcripts.** Contact your school early. *Allow 4-6 weeks for transcripts.*
- At least two (2) **letters of recommendation** must be attached and sent in with this application. Reference letters from your most recent employer, college instructor, FFA or ROP leaders, counselor, club/activity advisor or church leader are very helpful in assisting the committee in their selection of recipients. **It is recommended that you include one letter from your college major instructor.**
- Completed application forms, current transcripts and letters of recommendation must be returned to the Stanley W. Strew Educational Fund, Inc., C/O CAPCA @ 2300 River Plaza Drive, Suite 120, Sacramento, California 95833, **postmarked no later than May 11, 2012.**
- **Two scholarships will be awarded;** one from the California Association of Pest Control Advisers (CAPCA) for \$3,000.00 and one from Syngenta for \$2,000.00 to a senior actively pursuing a career to become a PCA.
- **Winners will be announced prior to July 13, 2012,** and scholarships awarded as deemed by the Scholarship Committee of the Stanley W. Strew Education Fund, Inc.
- **Incomplete applications will not be considered.**
- Scholarship checks will be awarded to the scholarship winners in summer 2011, pending receipt of proof of registration for the university term following July 2012.
