DPR UPDATES FOR SOIL FUMIGANT & NON-SOIL FUMIGANT LICENSEES

On December 8, 2023, DPR issued a notice to County Agricultural Commissioners which authorizes them to use discretion in enforcement of the new licensing and testing protocols for QAL and QAC holders with fumigant categories. If you are waiting to take an exam for the updated fumigant categories, please contact your local CAC to understand your options for purchasing and applying fumigants through March 30, 2024.
