License renewal season is here, and CAPCA is ready to help you navigate it with ease and confidence!

For over 30 years, we have been and continue to be the trusted source in CE tracking. In 2024, in response to DPR's 2024 regulatory updates, we developed and launched a modern, user-friendly platform: CE Hours Reported, available at **cereported.com**. This centralized tracking system is completely free for attendees and CE Sponsors—whether or not you're a CAPCA member—and is already utilized and trusted by over 300 CE Sponsors, with more joining every day.



When selecting CE courses to attend, look for the CE Hours Reported mark to ensure your hours are automatically tracked and applied toward your license renewal summary. While most sponsors use our new system, a few have chosen not to. To

ensure you're covered, we've added the **'Self-Report CE' tool** to your CAPCA dashboard, located under the CE Tracking and CAPCA Membership area.

If you attend a course from a non-participating sponsor (examples have been listed on our **DPR Renewal Hub** under the FAQ section), simply enter your Verification of Attendance or Certificate of Completion, and your hours will be

included in your renewal summary.

CAPCA is working tirelessly to ensure you have a fully documented CE renewal summary. Accurate, trackable documentation protects you in many ways—it supports your license, simplifies future renewals, and gives you peace of mind.

As a CAPCA Member, you are eligible to apply for UnitedAg's Vocational Scholarship Program!




